#### SECOND DAY.

Pursuant to adjournment the Association met and opened with prayer by Eld. Wm Blake. Minutes of yesterday's meeting were read and adopted.

The former Treasurer not having sent up his report. Bro. H Petty agreed to have him forward it at once to clerk of Association that it might be inserted in the minutes.

A Special Committee, adopted. (See report No. 10.) Committee on Finance, adopted. (See report No. 11)

The following resolutions were adopted:

RESOLVED. That the clerk be requested to superintend the printing and distribution of 300 copies of the minutes, and that he receive \$5.00 for his services.

RESOLVED, That we tender our thanks to the brethren and citizens of Annona for the kind and hospitable manner in which they have entertained us during our stay among them.

RESOLVED. That this body is in hearty sympathy with the management of the Buckner Orphan Home and urge upon our bretbren and sisters the importance of aiding in the support of those 50 orphan childern now in the Home.

Adjourned to meet at Mass Meeting, at 10:30 a.m., to-morrow.

# REPORTS.

NO. 1.—THE EXECUTIVE.

We, the Executive Board of Red River Association, submit the following report:

The Board met and organized September 3rd, 1882, and employed Eld. M Root as missionary for one month at \$50 00 per month, and determined to meet monthly at Paris.

Oct. 4th. The Board met and received the report of the missionary as follows: No. of sermons preached. 22; No. of exhortations. 15; No. of prayers, 40; No. of visits, 58; Miles traveled, 130; Churches organized, 1; Amount collected on the field, \$2.25. Continued the missionary in the field on same terms.

Nov. 17. The Board met and received report of missionary as follows: No. of sermons preached 18; No. of visits, 66; No. prayers, 35; No. of exhortations, 20; miles traveled, 100; amount collected on the field. \$4 00.

Dec. 17th. Board met and received missionary's report as follows embracing 17 days: No. of sermons, 5; Prayers, 11; Exhortations 12; Miles traveled, 62; Amount collected on the field. \$6.00. In view of the disagreeable weather the Board determined to suspend missionary operations till May next.

The Board was not able to get a quorum at the May meeting and nothing done and no other meeting was held.

By amount paid to missionary for two month, and seventeen days \$128 25.

Total ......\$128 25

Our missionary has been paid up in full and no other liabili-

ties have been incured by the Board.

The Board has made some effort to arrive at the truth in reference to the claim of the Rev, G F Mayer former missionary, but have been assured by the members of the former Board that employed him that there is nothing due him and your Board reports as their best information that there is nothing due said G F Mayer from Red River Association.

# NO. 3.—MINISTERIAL SUPPORT.

We, your Committee to whom was referred the subject of Ministerial Support would respectfully rebort the following:

Your Committee has not been able to ascertain the amount

paid the pastors by all the churches.

The following show the amounts paid pasters as far as we have been able to determine; Paris \$480 00. (for half time); Blossom Prairie \$150 00. (for one-fourth time); Union Grove

\$60 00 and Shamrock \$65 00.

In view of the fact that God has made it the duty of the church to preach His Gospel (through her ministers;) See Matt. 28:19. And whereas the "Lord has ordained that they that preach the Gospel shall live of the Gospel" 1 cor. 9:14, and whereas God has made it the duty of His people to contribute to His cause "as the Lord has prospered them," 1 cor. 16:2. We would therefore recomend that each church in this Association adopt a uniform system of contribution, so that our pastors and missionaries may be better supported and thereby enabled to give themselves "wholly to the work," wherever God has called them.

# NO. 4.—HOME MISSIONS.

Our Home Mission work is undergoing a crisis. More demands are now upon us for money and men than ever before. The General Association has twenty-two missionaries actively engaged at work, and there is a call for many more. Thousands of people on our frontier are entirely without Gospel preaching

and are crying unto us for assistance. In our own Association the apathy is deplorable. God will help us if we try to help ourselves. Your Committee is of the decided opinion that more active and progressive missionary work should be inaugurated. We therefore recomend the following:

RESOLVED. That this Association try to raise Five hundred dollars for missionary work and that we invite the Superintendant of Missions to assist us in raising that amount, and that we ask the General Association to regard our association as mission-

ary grounds and try to supply it.

We are glad to know that our colored brethren have made
such rapid progress since they have become free citizens among
us in the way of Literature and Religion, but we think it is the
duty of this Association to assist them in every way possible to
enlighten their minds to become useful citizens among us. We
accept the following amendment:

Whereas, The General Association has appointed Bro. W. H Parks to hold Ministerial Institutions among the colored

brethren in the State of Texas: Therefore,

RESOLVED 1. That we heartily approve the action and

pledge our co-operation in the work.

RESOLVED 2. That we cheerfully recommend Bro. Parks to the cofidence of our colored brethren and urge them to give him their moral support and co-operation in the work.

# NO. 7.—FOREIGN MISSIONS.

We, your Committee on Foreign Missions report that the work has peculiar claims on Texas at the present time for the following reasons, to-wit:

1. We have in Brazil Bros. Bagby and Taylor and their wives who are laboring in the Sunny clime to bring the inhabitants to Jesus, and are dependent upon their brethren and sisters in Texas to uphold them with their prayers and contributions.

2. We have in Mexico, our sister Republic, Bro. Powell and wife and Miss Maybray who have given their lives to the dusky inhabitants of that nation and are meeting with grand success, reciving numbers at almost every meeting, and having a contin-

ual revival in the church at Saltillo.

3. Bro. Keifer has sold his farm to go to Germany to preach Christ to the Germans. Within ten months of last year he had 1800 conversions and the natives flock to him in crowds to hear the Gospel preached. All these have left our own heloved State and God has placed before us an open door which we should delight to enter and thus assist by prayer and contribution to carry out the great commission of our Lord.

We recommend that these matters be laid before each of our churches and a contribution be taken in November and sent to Bro. A J Holt, Dallas, to be appropriated to our Texas Mission-

aries in Foreign Fields.

### Rules of Decorum.

1. After the introductory sermon shall have been preached the moderator of the next preceeding year (if present or if he be absent a moderator protem) shall call the delegates together and after prayer cause the letters from the churches to be read and a list taken of the churches and delegates by the clerk of the preceeding year if present, if not present, then by a clerk protem.

2. The Association shall elect a Moderator, Clerk and Treas-

urer by private ballot.

3. Letters and Messengers from new churches called for.
4. Letters from corresponding Associations and visitors called for.

5. A Committee on divine service shall be appointed who shall arrange for preaching during the Association and report to the moderator who shall make a public announcement of it.

6. A committee shall be appointed to write a corresponding

letter to sister Associations.

- 7. Call for report of Executive Committee and dispose of same.
  - 8. Treasurer's report and settlement with Executive Board.

9. Elect an Executive Board for next year.

10. Appointing various committees by moderator.

11. Select some one to preach next introductory sermon, and a place for holding the next meeting.

12. Appoint corresponding messengers to sister Associations.
13. Every person desiring to speak shall rise to his feet and address the moderator and shall not be interrupted while speaking unless he departs from the subject, or indulges in personal reflections; in either case, the moderator shall call him to order, and no one shall speak on the same subject oftener than twice

without leave of the moderator or Association.

14. No delegate shall absent himself from the Association

without permission of the moderator or Association.

15. All business shall be introduced by motion and second or in form of a resolution and decided by a majority except in anything touching fellowship in which unanimity shall be required.

16. A call shall be made for motions and resolutions.

17. These Rules may be amended at any regular meeting by a vote of a majority of the Association.
