#### HOME MISSION BOARD.

The Home Mission Board of the Southern Baptist Convention, located in Atlanta, Ga., has been helping in the preaching of the gospel in Texas, from the time of the Texas Republic, and is still helping us, expending the sum of \$600.00 within our state in destitute fields during the past conventional year. A large majority of the first churches in the center of influence in the state have been organized and pushed into prominence under the fostering care of this Board. Under its lead the Baptists of the South have become the leading religious denomination, the progress by far exceeding that of the Northern States under their methods of work. Texas, during all her history, has maninly been a beneficiary of this Board, and the benefits derived, no finite mind can conceive, and of the grand results eternity alone will reveal. Therefore, we your Committee recommend that this association lend a helping hand in this grand work, and that every church within its bounds be requested and urged to take up a collection for the same at least once a year and forward to the corresponding secretary of the State Convention to be applied in the cause of Christ for the up-building of His Zion

in the waste places, that they may be made to blossom as the rose, and to produce abundant fruit to the honor and glory of God.

#### OLD MINISTERS' RELIEF. .

Your committee to whom was assigned the duty to report upon the above, submit the following: This work was begun by our State Convention about three years ago. They have a regular board for the management of its matters, with an efficient secretary, Rev. H. M. Burroughs, of Waco, Tex. They are now aiding about thirty-five beneficiaries, who are either the old, infirm ministers or their widows. These men bore the heat and burden of the day; doing faithful work for Christ in Texas, until they became so enfeebled that they could work no longer, but who in their life of labor had not looked to worldly matters, and as old age drew on found themselves without anything for support. Our object is to aid them now, for work long since performed. In our judgment there is nothing that has stronger claims upon us than those old veterans. Shall we see them suffer? or shall we show our appreciation of their work by a regular divide of our means, that their last days may not be passed in squallid misery. #### DECLARATION OF FAITH.

#### I. OF THE SCRIPTURES.

We believe that the Holy Bible was written by men divinely inspired, and is a perfect treasure of heavenly instruction; that it has God for its author, salvation for its end, and truth without any mixture of error for its matter; that it reveals the principles by which God will judge us; and therefore is, and shall remain to the end of the world, the true center of Christian union, and the supreme standard by which all human conduct creeds, and opinions should be tried.

#### II. OF THE TRUE GOD.

We believe that there is one, and only one living and true God, an infinite, intelligent spirit, whose name is Jehovah, the Maker and Supreme Ruler of Heaven and Earth; inexpressibly glorious in holiness, and worthy of all possible honor, confidence and love; that in the unity of the God-head there are three persons—the Father, the Son and the Holy Ghost—equal in every divine perfection, and executing distinct but harmonious offices in the great work of redemption.

#### III. OF THE FALL OF MAN.

We believe that man was created in holiness, under the law of his Maker; but by voluntary transgression fell from the holy and happy state; in consequence of which all mankind are now sinners, not by constraint but choice; being of nature utterly void of that holiness required by the law of God, positively inclined to evil; and therefore under just condemnation to eternal ruin, without defense or excuse.

#### IV. OF THE WAY OF SALVATION.

We believe that the salvation of sinners is wholly of grace; through the mediational offices of the Son of God; who by appointment of the Father, freely took upon him our nature, yet without sin; honored the divine law by his personal obedience, and by his death made a full atonement of our sins; that having risen from the dead, He is now enthroned in heaven; and uniting in his wonderful person the tenderest sympathies with divine perfections. He is every way qualified to be a suitable, a compassionate and an all-sufficient Savior.

#### V. OF JUSTIFICATION.

We believe that the great gospel blessing which Christ secured to such as believe in Him is justification; that justification includes the pardon of sin, and promise of eternal life on principles of righteousness; that it is bestowed, not in consideration of any works of righteousness which we have done, but solely through faith in the Redeemer's blood, by virtue of which faith His perfect righteousness is freely imputed to us of God; that it brings us into a state of most blessed peace and favor with God, and secures every other blessing needfull for time and eternity

#### VI. OF THE FREENESS OF SALVATION.

We believe that the blessings of salvation are made free to all by the gospel; that it is the immediate duty of all to accept them all by a cordial, penitent and obedient faith; and that nothing prevents the salvation of the greatest sinner on earth, but his own inherent depravity and voluntary rejection of the gospel; which rejection involves him in an agravated condemnation.

#### VII. OF GRACE IN REGENERATION.

We believe that in order to be saved, sinners must be regenerated, or born

again; that regeneration consists in giving a holy disposition to the mind; that it is effected in a manner above our comprehension by the power of the Holy Spirit, in connection with Divine truth, so as to secure our voluntary obedience to the Gospel; and that its proper evidence appears in the holy fruits of repentance and faith, and newness of life,

#### VIII. OF REPENTANCE AND FAITH.

We believe that repentance and faith are sacred duties, and also inseparable graces, wrought in our souls by the regenerating Spirit of God; whereby being deeply convinced of our guilt, danger and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession and supplication for mercy; at the same time heartily receiving the Lord Jesus Christ as our Prophet, Priest and King, and relying on him alone as the only and all-sufficient Savior.

#### IX. OF GOD'S PURPOSE OF GRACE.

We believe that election is the external purpose of God, according to which He graciously regenerates, sanctifies and saves sinners; that being perfectly consistent with the free agency of man; it comprehends all the means in connection with the end; that it is a most glorious display of God's sovereign goodness, being infinitely free, wise, holy and unchangeable; that it utterly excludes boasting and promotes humility, love, prayer, praise trust in God, and active imitation of His free mercy; that it encourages the use of means in the highest degree; that it may be ascertained by its effects in all who truly believe the Gospel; that it is the foundation of christian assurance, and that to ascertain it with regard to ourselves demands and deserves the utmost diligence.

#### X. OF SANCTIFICATION.

We believe that sanctification is the process by which, according to the will

wicked, and under the curse; and this distinction holds among men both in and after death.

#### XVIII. OF THE WORLD TO COME

We believe that the end of this world is approaching; that at the Last Day Christ will descend from heaven, and raise the dead from the grave to final retribution; that a solemn separation will then take place; that the wicked will be adjudged to endless punishment, and the righteous to endless joy; and that this judgment will fix forever the final state of men in heaven or hell, or principles on righteousness.
