THE PERILS OF OUR TIMES

II Timothy 3:1
Moderator's Address, Longview, Texas

A peril is exposure to chance of injury, loss, destruction, danger. There were perils in Paul's day. In fact, Paul was stoned, beaten, jailed and finally beheaded in Rome. This was because of his stand for Jesus. John, the Baptist, lost his head. Peter was crucified. Others died martyrs' deaths. These were perilous times indeed.

During other years, preachers, laymen, women and children gave their lives for their faith in Jesus. They were drowned, burned, and beaten, yet grew mightily. Fifty four million died because of their faith in Jesus Christ. Those were perilous time.

But today let's note some perils of our times; they may be greater than you think.

THE PERIL OF THE PRINTED PAGE

By this I refer to printed materials that put an ax to the pen of inspiration. One such attack was the **REVISED STANDARD VERSION** published in 1952. We shall note two excerpts from the booklet, "Debate Over the New Bible" by Dan Gilbert:

"Religious liberalism rejects the idea that there is any such thing as a Holy Bible. The new translators have demonstrated that the Bible is not a Holy Book. They have treated it as a human book." ("Debate Over the New Bible" page 13.)

Prof. Stevenson stated:

"The new Bible is our text book. It is an agency of enlightenment, which we want to put into the hands of all people of religious sensibility. The old Bible belongs to the dead past. It upholds the old superstitions that we want to tear down. Religious liberalism needed a new Bible to serve its purposes. The best scholars in the world have given it to us." (Ibid page 17)

Another attack on man's faith in God is **Good News For Modern Man**. The publishers of this book have tried to put a copy in the hands of every man woman, boy and girl. One example in point is Acts 2:38 which reads:

"Peter said to them: Turn away from your sins, each one of you, and be baptized in the name of Jesus Christ, so that your sins will be forgiven; and you will receive God's gift, the Holy Spirit."

This of course, teaches baptismal regeneration and is adding to the Word of God.

Today many schools of theology deny the Virgin Birth of Jesus and the miracles of the Bible. Indeed we live in perilous times.

THE PERIL OF ECUMENICALISM

Ecumenical is defined as: belonging to or accepted by the Christian Church throughout the world; general, universal. Or, a universal church composed of all denominations. This perfidious, false, faithless churches do, but true Christianity never. Missionary Baptists must hold the line. We must stand by our distinctives.

True Christians cannot have Christian fellowship with those who:
practice and teach baptismal regeneration;
hold hands and fellowship with communists;
those who reject Jesus as the Divine Son of God;
those who trample under foot the Divine Word of God;

those who call the Bible an obsolete, outdated book.

God calls for men who will stand in the gap. Ezk. 22:30. Missionary Baptists must hold the line, and to do this, we must be united. We must stand against wrong as well as for right.

THE PERIL OF DEGRADATION

Degradation is the state of being reduced in rank or disgraced. Degradation is world wide. The strong arm of the law is not so strong any more. Crime is on the increase. It has gotten so bad, it has become a political football.

Many churches have degraded from the high ideals of the past. Church discipline, a New Testament Doctrine, has been forgotten. That old time Pentecostal power has been lost. Some churches have left their door open to worldly affairs, a few ministers have lowered to such actions and demonstrations that defy the laws of our land. Our duty is to preach the Word. II Timothy 4:2.

Marriage laws are now old fashioned and forgotten. Very few boys and girls finish High School a virgin. Very few complete school without at least trying drugs. Such unions will produce offsprings that are deformed, impious, daring characters and prophecy is being fulfilled. "But as the days of Noah were, so also shall the coming of the Son of man be." Matt. 24:37.

FOR THE TIME THAT IS LEFT LET'S RISE TO THE ISSUE

Surely we live in perilous times. Our Lord will soon return and demand of us to account for our actions. But for the time that is left, let's unite ourselves, dedicate ourselves, and really count for Christ. One day this Association will have met for the last time, it could be today. This could be the last session before Jesus returns. Let's make it the best one ever.

Let's join hands in this great fight for our God and build the greatest mission work ever.

MINUTES OF THE MISSIONARY BAPTIST ASSOCIATION OF TEXAS

November 11, 1970
WEDNESDAY MORNING

Services were opened with the congregation singing "Love Lifted Me" and "Saved by the Blood" led by Eld. Jim Slocumb with Mrs. Dale Crosby at the piano and Mrs. Wendel Owens at the organ.

Eld. Havis McBride led the opening prayer.

The moderator, Eld. Gordon Shaffer, called on Eld. Roy Lane to bring the morning devotional. Bro. Lane read I Corinthians 16:8, 9, and spoke briefly on "An Open Door in Christian Service." He led in prayer.

The host pastor, Eld. George Crawford was recognized to bring the welcome from the host church. He introduced the other host pastors, Eld. Bill Voss of White Oak and Eld. George White of Greggton. Bro. Voss spoke words of welcome and presented the Mayor of White Oak, the Honorable Bill Bean. Bro. George White also welcomed the assembly and introduced Patrolman B. W. Acker who welcomed the assembly on behalf of the Longview Police Department.

Mayor Bean is a member of the White Oak Missionary Baptist Church and Patrolman Acker is a member of the Greggton Missionary Baptist Church.

Bro. Crawford also spoke words of welcome on behalf of Unity Missionary Baptist Church of Longview who was without a pastor at this time.

Eld. Ken Ashlock gave the response to the welcome.

The moderator, Eld. Gordon Shaffer, asked the congregation to stand as he declared the 1970 session of the Missionary Baptist Association of Texas open for the transaction of business. Eld. Augustus Downing led in prayer.

Enrollment envelopes were called for and received by the committee.

Eld. Ray Brooks, assistant moderator, was recognized while the moderator delivered his address entitled "The Perils of Our Time." His text was II Timothy 3:1.

A motion was made that the address be printed in the yearbook. The motion carried.

Bro. Brooks turned the chair back to Bro. Shaffer.

Eld. W. H. Hitt made an announcement concerning the condition of Bro. Garland Hines of Clarksville, who was seriously ill. Prayer was requested for the mother of Bro. Joe R. Brooks and Mrs. J. W. Harper. Eld. Leo Massie led in this special prayer.

The moderator called for the election of officers.

Eld. Ray Brooks was nominated and elected as the new moderator.

Those nominated for assistant moderator were Elders G. D. Walters, Lee R. Tillman, Ken Ashlock. Eld. Walters was elected.

A motion was made to retain the same clerks, Elders Harold Davis and Billy Daniels. Motion carried.

A motion was made to retain Eld. J. W. Griffith as auditor. Motion carried.

Eld Bill Hitt was nominated and elected as the Corresponding Secretary and Treasurer.

Nominations for the annual sermon for 1971 were called for. Those nominated were: Elders Raymond Alexander, Jack Strickland, Bill Knight, Gilbert Sparks, Vernon Barr, James Crawford.

A motion was made and passed that the one receiving the second highest number of votes be the alternate.

Bro. Alexander was elected with Bro. Barr as the alternate.

A motion was made that State Missions be the special order of business in the afternoon session. Motion carried.

A motion was made that Christian Education be the special order of business in the evening session. Motion carried.

A motion was made that Interstate and Foreign Missions be the special order of business after the State Mission Report. Motion carried.

A motion carried to elect a speaker for the evening service.

Eld. Michio Kawahara, Missionary to Japan, was nominated and elected.

The Enrollment Committee asked for a count of messengers and visitors at this time. The number of messengers counted was 275.

A motion was made to select a meeting place for 1971. Motion carried and invitations were called for. Fellowship Missionary Baptist Church of Pasadena was the only invitation and was accepted.

Eld. Jim Adams introduced the speaker for the annual message, Eld. James A. Kirkland.

Eld. Jim Slocumb and David Bassett sang, "I Discovered a Way of Gladness," accompanied by Mrs. Dale Crosby at the piano.

Bro. Kirkland read Acts 6:1-7 and spoke on the subject, "The Modern Pastor's Dilemma."

The moderator called for Dr. A. J. Kirkland to extend the hand of appreciation for the message.

A motion carried to adjourn until 2:00 p.m. Announcements were made and Eld. Earnest Moyers led the closing prayer.

WEDNESDAY AFTERNOON

Eld. Ray Brooks called the meeting to order. Bro. David Bassett led the congregation in singing, "I Am Resolved" and "My Saviour's Love" with Mrs. Dale Crosby at the piano and Mrs. Wendel Owens at the organ.

Eld. Carroll Jones led in prayer.

State Missions was the order of business and Eld. W. H. Hitt was called on for his report. Bro. Hitt called all the missionaries to the front and presented his Financial Report. He explained that the books had not been audited due to the fact that the auditor, Bro. J. W. Griffith was in the hospital and that the books would be audited as soon as Bro. Griffith was able to do so.

A motion was made to adopt the report as printed. The motion carried.

Bro. Hitt gave his evaluation of the work of each missionary for the past year.

Bro. Hitt read the following recommendations:

Eld. Gordon Shaffer endorsed and recommended for salary by the First Missionary Baptist Church, Hobbs, N. M.

Eld. Kenneth Griffith endorsed and recommended for salary by the Chapelwood Missionary Baptist Church, Huntsville, Texas.

Eld. Carl Hashaw endorsed and recommended for salary by the Good Shepherd Missionary Baptist Church, Shepherd, Texas.

Eld. Jim Slocumb endorsed and recommended for salary by the Oaklawn Park Baptist Church, Midland, Texas and also the Westwood Baptist Church of Odessa, Texas.

Eld. J. C. Askew endorsed and recommended for designated funds by the Liberty Missionary Baptist Church, Ft. Worth, Texas.

The missionaries were called on to give their reports.

Eld. Marion Reed reported that the Golden Meadows Mission in North Garland had organized into a church. He expressed his appreciation for the support of the past year and stated the church would no longer need the financial support of the churches.

Eld. Jim Slocumb reported on the work in Midland.

Eld. Kenneth Griffith reported on the work in Huntsville. Eld. Ray Brooks and Eld. Luther Crawford also spoke concerning Bro. Griffith's report.

Eld. Carl Hashaw reported on the work in Cenroe.

Eld. Gordon Shaffer reported on the work in Albuquerque. He reported that the mobile unit had been in use there since February.

Eld. Joe Askew reported on the Unity Baptist Church, Wichita Falls and his plans and efforts in Ft. Worth.

A motion was made to have the same number as had come recommended (four on salary and one on designations) and those who came recommended stand as nominees. The motion carried.

Bro. Kenneth Griffith asked to be voted on separately. Brethren Shaffer, Hashaw and Slocumb were elected for salary and Bro. Askew for designated funds.

Brethren Vernon Barr and Don Melton spoke for Bro. Griffith. Bro. Griffith was unanimously elected.

Bro. Hitt recognized Eld. Robert Myers of Denton, who spoke concerning the recommendation made in last year's M. B. S. F. Report. A motion was made to take under discussion the proposition of electing a full time M. B. S. F. Representative with the same salary as the missionaries. The motion carried.

The recommendation was discussed by several brethren.

A motion was made that we definitely come next year with someone in mind to elect and put on the field.

An amendment was offered to the motion that we look forward to the May meeting of the Missionary Committee meeting and if someone comes recommended and worthy of support, the matter be taken up there.

The motion was restated as follows: that in the May Missionary Committee meeting that we take up election of a full time Missionary for the M. B. S. F. work if one comes recommended by the church of his membership and is qualified. Motion carried.

The State Missions Report was recessed at this time and the Interstate and Foreign Missions report was read by Eld. A. L. Patterson. A motion was made to adopt. The report was spoken to by Bro. Patterson. The motion to adopt carried.

Bro. Hitt was recognized for a continuation of the State Mission Report. He asked Eld. Jim Robertson, pastor of Unity Missionary Baptist Church, Wichita Falls, to speak concerning the condition of the church there.

Questions directed to Bro. Robertson led to a discussion by several brethren. The moderator ruled the discussion closed.

A motion was made that the Unity Baptist Church, Wichita Falls and her pastor be put on designated funds until such time as they are out of financial difficulty. A request was made that the church keep the people informed through the papers (Baptist Monitor). The motion carried.

Bro. Askew spoke in reference to a personal matter. The moderator stated that he had asked that the discussion be left off. A motion was made to sustain the ruling of the chair. Motion carried.

A motion was made to retain the special Missionary Committee with the expectation that Eld. Paul Cherry replace Eld. Charles French. Motion carried.

A motion was made to adjourn until 7:00 p.m. Announcements were made. Eld. O. H. Griffith led the dismissal prayer.

WEDNESDAY EVENING

Services were opened with the congregation singing "He is Able to Deliver Thee" led by Bro. Glen Moore of the local church. Eld. Bill Voss led in prayer.

Eld. George Crawford was recognized to present the choir of the Longview Missionary Baptist Church for a special music program.

Bro. D. W. Barnes assisted by Bro. Glen Moore led the choir with Mrs. Dale Crosby at the piano and Mrs. Wendel Owens at the organ.

Following the special music, Bro. Shaffer called attention to a prayer request for a member of the Waterview Missionary Baptist Church, Richardson. Eld. Bruce Hibbitt led in prayer.

Dr. A. J. Kirkland was recognized to give the Christian Education Report. A motion was made to adopt the report with the understanding that the financial statement would be printed in the yearbook. The report was spoken to by Elders Vernon Barr, L. Chester Guinn, Ray O. Brooks. The motion to adopt the report carried.

Bro. Moore led the congregation in singing "Count Your Blessings."

Eld. Bill Voss introduced the speaker, Eld. Michio Kawahara, to bring the evening message. The speaker, a native of Japan, has been attending the Seminary in Little Rock. He is due to return to Japan as a missionary to his people.

Bro. Kawahara brought an outstanding message using Joshua 24:15 as his text.

Eld. Augustus Downing extended the hand of appreciation to the speaker on behalf of the congregation.

A motion was made to receive an offering to be divided between Bro. Michio Kawahara and the instructors on designated funds at the Mexican Baptist Institute, (Elders H. C. Henson, Larry Romero, J. L. Mitchell). The motion carried.

The choir sang a special while the offering was received.

A motion was made to adjourn until 9:00 a.m. Thursday morning. Motion carried. Announcements were made. Eld. James Kirkland led the dismissal prayer.

THURSDAY MORNING

Services opened with the congregation singing "The Banner of the Cross" led by Bro. Gary Fulfer.

Eld. Joe Stevens of Snyder was called on to bring a devotional. He read Ezra 8:21-23 and spoke on the thought "Our God Will Hear."

Eld. Ray O. Brooks was acting as moderator.

A motion was made that \$100.00 of the Secretary-Treasurer's salary be designated as office help. An amendment was offered that the Secretary-Treasurer be paid \$100.00 for office help. A substitute motion was made that we give the Secretary-Treasurer an increase of \$100.00 per month designated as office help and an increase of \$50.00 per month to the missionaries. The substitute motion carried.

A motion was made that \$150.00 per month be counted as housing and utilities. Motion carried.

A motion was made to have one Missionary Committee meeting and that it be in May. Motion carried.

An invitation was given to meet at the Calvary Baptist Church, Henderson in connection with the closing exercises of Texas Baptist Institute. A motion carried to accept this invitation.

A motion prevailed to consider the proposed changes in the Mission Policy that were presented to the Missionary Committee meeting in May 1970.

A motion carried that the proposed changes be read and acted upon by sections.

Eld. Augustus Downing read the proposed change for Section II. A motion was made to adopt. Motion carried.

Bro. Downing read the proposed change to Section VI. A motion was made to adopt this section. A motion was made to amend the section and leave out the last sentence which read, "The two revival meetings that no funds are reported from must be the first two meetings he holds within the Associational year." This amendment carried.

A motion was made to amend the section and that the monies paid by the Mission project for Social Security not be counted as salary. This amendment carried.

A motion was made that the Mission project could, if they so choose, pay for the missionary's gas up to \$10.00 per week without being reported. A motion was made to amend the amendment that the statement in the Mission Policy "money collected on the field" be money paid by the mission on the missionary's salary, or paid for revivals which he keeps, or money which is designated to be reported on salary.

A substitute motion was made that a committee be elected to study this section and prepare proposals to be presented next year. The substitute motion carried.

Bro. Downing read the proposed change for Section VIII, Article 2. A motion was made to adopt after the statement "or Mother" was struck out. A motion was made to amend by striking out the words, "that is of sufficient strength to fulfill the responsibility of a sponsoring or "Mother church." The motion to amend did not carry. The original motion was voted on and passed.

The proposed change to Section VIII, Article 3 was read. A motion was made to adopt by adding the word "within" in the sentence, "that this be done by seeking to support 20% of the missionary's salary (within) the first year," etc. The motion to adopt as changed carried.

The proposed addition of Article 2 to Section VIII was read and a motion was made to adopt. The motion carried.

An additional amendment to the proposed changes was read. No action was taken.

A motion was made to add Section X to the Mission Policy as follows: "May the statements of this policy never be interpreted as binding laws upon churches or missionaries, but as goals and guidelines." The motion carried.

A motion was made to elect three men to study Section VI of the Mission Policy. Those nominated were: Elders James Kirkland, Augustus Downing, Elvin Crocker, Gordon Shaffer, Ray Brooks, Havis McBryde. Billy Daniels, Bill Hitt.

A motion was made that the salaried missionaries working with Bro. Hitt serve on this committee. The motion was defeated and nominations continued.

A motion was made that the one receiving the highest number of votes serve as chairman. Those elected were Brethren Kirkland, chairman, McBryde and Hitt.

A motion was made that this group of messengers express the view that for this year only the missionaries not be asked to report as contributions toward salary the following: (1) What their mission pays on their Social Security tax, or (2) up to \$10.00 per week gasoline expenses. The motion carried.

A motion was made that the Secretary-Treasurer be allowed nine cents (.09) per mile plus other actual expenses for travel. Motion carried.

A motion was made to pay the missionaries actual expenses incurred in travelling to the Missionary Committee meeting in May. Motion carried.

The "Suggested Guidelines for Use of Mobile Units" were read. A motion was made to adopt these suggested guidelines. The motion carried.

Bro. Brooks turned the moderators chair back to Bro. Shaffer.

Eld. Raymond Alexander was recognized to read a resolution concerning protest marches and rallies. A motion was made to adopt. The motion carried.

The report on Civic and Social Relations was read by Eld. John Paul Jones. A motion was made to adopt. The report was spoken to by Bro. Jones and the motion to adopt carried.

The report on Young People's Work was read by Eld. Dee Rogers. A motion to adopt the report was made. Bro. Rogers spoke to the report and the motion to adopt carried.

The Benevolence Report was read by Eld. Elvin Crocker. A motion was made to adopt. Eld. Havis McBryde spoke to the report. The motion to adopt carried.

The report on M. B. S. F. work was read by Eld. Robert Myers. A motion was made to adopt. The report was spoken to by Elders Myers, George White, Vernon Barr, and Sister George Goodman. The report was adopted.

The report on Women's Work was read by Sister Linda Ashlock and a motion was made to adopt. The report was spoken to by Sister Ashlock and it was adopted.

Eld. James Kirkland read the report on Publications. A motion was made to adopt. The report was spoken to by Eld. O. H. Griffith. The motion to adopt the report carried.

Eld. Augustus Downing read the Financial Committee's report. A motion was made to adopt and it carried.

The Enrollment Committee report was read by Eld. Calvin Permenter. A motion was made to adopt the report. Motion carried.

A motion was made to ask the host pastor to serve as Publicity Director and that he be allowed to spend up to \$75.00 for expenses. The motion carried.

Eld. Robert Myers was nominated for M. B. S. F. Representative and was elected.

Eld. Norman Pierce read the Resolutions Committee Report. A resolution of thanks to the host church was presented. A motion to adopt was made and carried.

A motion was made to pay the clerks \$100.00 each and the Auditor \$75.00. Motion carried.

A motion prevailed to elect a committee of three to look into the possibilities of establishing a camp for Texas and New Mexico.

Those nominated for this committee were: Elders Marion Reed, L. Chester Guinn, Jim Adams, Ken Ashlock, D. B. Wright, Bill Voss, Luther Crawford.

A motion carried that the one receiving the highest number of votes serve as chairman.

Those elected were Brethren Guinn, chairman, Adams and Ashlock.

A motion was made to adjourn until next year when we meet in Pasadena. Motion carried.

The moderator turned the chair over to the new moderator, Bro. Brooks. Bro. Brooks recognized the other officers.

Eld. Gene Smith spoke words of invitation for next year as host pastor and Publicity Director.

Other announcements were made. The closing prayer was voiced by Eld. H. L. Strickland.

CHRISTIAN EDUCATION REPORT

There are several phases of Christian Education such as Sunday School, Summer Encampments, Baptist Training Course, Vacation Bible Schools and Missionary Baptist Student Fellowships. And since there will be special reports dealing with these worthy causes, this report deals only with the work of Texas Baptist Institute. This will be a limited, summary report as we will furnish the recording secretaries with the itemized annual report which will be published in the Year Book.

We leave to Bro. Vernon L. Barr the report on the A.B.A. Mexican Baptist Institute.

First of all we think it is of great importance that we have the largest student body in all the twenty three years of our history. We have enrolled 78 students in actual class room work. There are 68 ministers, nine women and one layman.

We are happy to announce that the Alumni effort to raise the seven thousand dollars for this school year has been a success. It is practically impossible to say just how much the campaign brought in, for many just raised their regular offering and did not mark it special, but we base our report on the fact that we have more money in the treasurer than we had at this same time last year. If the regular offerings hold up as they usually do, we will be able to reach the end of the school year with all bills paid for the current year.

With our continual growth, there are always increasing needs. We must plan for more student housing so that it will make it easier for students to live without paying high rent. Your trustees, and Calvary Baptist Church, have recently purchased one and one-half acres of beautiful ground across the street and one block north of the administration building. This block of ground fronts on two streets and there is room for four or five buildings on it. We purchased this ground for \$5,000.00 (Five thousand dollars) paying \$1,000.00 down, and we hope to pay the balance by June 1, 1971 and build another dormitory in time for use next Fall.

The enlargement on the auditorium of the administration was made this year as planned.

With the large student body, other needs arise. We need more supplies for the store room and more money for student aid. We are happy to report that the support for these needs are still growing. In our school families, there have been four babies born this year, and we are expecting at least one more. With student aid we have been able to help each family to pay the hospital bill.

We can say most sincerely that all the students appreciate the help of this student aid and store room supplies without which some could not possibly stay in school.

We gratefully express our thanks to all the churches and brethren for the wonderful support given and we pray that we shall continue to merit your confidence.

So, with the combination of sight and sound the Word of God is more firmly implanted in our minds and hearts.

The Lord's wisdom should instruct us, and it has instructed us, because long ago our Baptist people recognized the immense value of publications. The earliest kind of literature among them was doctrinal treatises setting forth their distinctive beliefs, then the independent Baptist papers which helped to mold the Baptists doctrinally and to inspire them denominationally, and finally the publications houses were established to provide study materials for Baptist Churches and their auxiliary organizations. Baptist growth has given ample evidence that they were wise to follow the Lord's wisdom in not only speaking but also printing the truth.

The Missionary Baptist Association has no official state paper. Unofficially the **Baptist Monitor** has served as a forum for the discussion of issues and a source of information concerning the work of the churches. This paper has had an immeasurable influence on the development of our associational work. We continue to urge every church in our fellowship to place the **Baptist Monitor** in every home so that we may have an informed Baptist people.

The Missionary Baptist Association has no publications house of its own in the state, but with the other churches composing the American Baptist Association, uses the services provided by the Baptist Sunday School Committee. It is gratifying to note that the literature business in Texarkana continues to grow. In the 1970 messenger meeting of the A.B.A. in Louisville, Ky., it was possible for the Business Manager to report that the business had

shown an increase in sales over 1969 of \$103,866.89 and a new profit during the year of \$52,149.96, indicating that this has been one of the best years in recent history. Our people should be reminded that the literature business does not exist to make a profit; however, it must make a profit to continue to exist and to enlarge its services to the churches.

The Baptist Sunday School Committee through the editor's office and the business manager's office is endeavoring to enhance the quality of teaching materials provided our churches to aid them in having a higher quality of instruction in their educational programs on the local level. We should gladly give them our word of appreciation for the commendable work they have done in fulfilling this responsibility to the churches.

Within the past month information has been released to the churches of the American Baptist Association advising them that the majority of churches voting on the new publications facilities in Texarkana approved the project. We do not have any information regarding how many of our Texas churches voted or what percentage of them approved the project, but inasmuch as a majority voting throughout the nation has approved the program, we urge our Texas churches in the best tradition of cooperation which has characterized Texas Baptists for the past twenty years to give liberal support to this program. Only a unified effort nationwide can accomplish the fulfillment of this program.

Last year's report on Publications in our state meeting urged an appeal to Editor-in-Chief, O. H. Griffith, to consider scheduling a writer's conference, as soon as possible, to encourage and help those among our people who have an interest in writing for Christian Publication. Others had made a similar appeal to the Editor's Office. We are pleased to note that these appeals have been taken under consideration and plans are presently being made to begin such conferences as soon as they can be planned and scheduled.

A brief list of M.B.S.F. needs appears on Page _____ of this year book and other information is given on the back cover.

We urge our pastors and churches to utilize the M.B.S.F. as an aid in encouraging, winning, and preserving our young people and we urge the support of the M.B.S.F. work around the state.

Further, let us unite together in earnest prayer that God will provide a full time state worker for this special and vital field of labor—the Missionary Baptist Student Fellowship.

This means, in all probability, that the Texas State Legislature will pass a law giving the right of local option elections. In order to effectively oppose this, pastors should keep informed. If the law is passed, they should acquaint themselves with every aspect of it. They should watch for the calling of a vote in their locality and be prepared to oppose it. This may be done by reminding the citizenship of the serious moral and economic effects of liquor by the drink. Also by working to get people out to vote in opposition to it, the measure may be defeated.

STATEMENT OF MISSION POLICY

SECTION I

The messengers of the churches of the Missionary Baptist Association of Texas will not recommend any man to the mission field unless he has first

been elected or endorsed as a missionary by the church of his membership, said church being associated with, and subscribing to the principles and practices of the churches of the Missionary Baptist Association of Texas.

SECTION II

Each church recommending a missionary from their membership to the churches of the Missionary Baptist Association of Texas in annual session is requested to submit for public reading a brief summary of the activities of the recommended missionary in the ministry that the messengers may know something of the abilities, training, and work of the man; and that the church recommending the missionary give a statement as to what their plans are concerning the support of the missionary and his area of work. This information will greatly aid the messengers from the churches in making their decisions about individual missionaries.

SECTION III

We recognize that a missionary elected by his local church, if it be a Scriptural church is a Scriptural missionary, without recommendation of the messengers from the churches of the Missionary Baptist Association of Texas.

SECTION IV

Any messenger may request an individual vote on any name recommended for endorsement by the messengers in annual session.

SECTION V

We recognize as Scriptural the right of the messengers in annual session to recommend stipulated salaries for the missionaries.

SECTION VI

All missionaries of the churches working as State Missionaries under the recommendations of the messengers shall make a written monthly report to the Secretary-treasurer. This report shall tell of the work done during the month and shall list all money collected on the field. Reports shall be made available to the churches and a yearly report published in the minutes. Money collected on the field, unless designated to some special church or mission project, shall be counted as salary. The missionaries and Secretary-Treasurer may hold as many as two revival meetings each year without reporting any funds, so received, as contributions toward his salary. The missionaries and the Secretary-Treasurer may have two weeks paid vacation each year in addition to two revival meetings.

SECTION VII

State Mission work shall be defined as follows:

1. Work in cities where we have no Missionary Baptist Churches, or in cities large enough to have two or more churches.
2. Work with weak pastorless churches, to aid them in growing and securing a pastor.
3. Although we look with favor on revival meetings, revivals in established churches with regular pastors, should not be counted as mission work.
4. A month's work should include at least 160 hours actually spent in constructive mission work.

SECTION VIII

We recommend:

1. The missionaries seek fields in sections of the state where we have no churches.

2. The missionaries should seek out a church to sponsor the mission that is consistent in their support of missions, and that is of sufficient strength to fulfill the responsibility of a sponsoring church, and that the sponsoring church adopt a policy concerning the mission that would not allow it to be organized into a church until it becomes self-supporting in every respect, including a full time pastor on the field.
3. That the missionaries begin teaching and leading newly organized missions and churches to support all phases of mission work and that they begin immediately to give support to the missionaries salary, and that such support be increased regularly as the work grows. The missionary and mission should work toward a goal of being able to support a pastor within five (5) years. That this be done by seeking to support 20% of the missionary's salary within the first year, 40% within the second, 60% within the third, 80% within the fourth, and within the fifth year of being able to support a full time pastor. The missionary should remain with the mission until it becomes self-supporting.
4. That the missionaries seek to lead the newly organized churches to adopt, and put to proper use, a good Sunday School record system and plan of Sunday School organization.
5. That the missionaries lead the newly established churches to follow a definite plan of organized visitation evangelism.
6. That the missionaries not be used as a supply preacher in our established churches where pastors are on the field.
7. That missionaries not pastor a church that is recognized as a self-supporting church, regardless of how much of his salary they might pay.
8. That the missionaries should not be elected to an office of the Association.

SECTION IX

The trustees of the Missionary Baptist Association of Texas are authorized to relocate old mobile church units and locate new ones between sessions of the association under the following guidelines:

1. State missionaries of this association on stipulated salary be given priority for usage of mobile units;
2. State missionaries of this association on designated offerings be eligible for mobile units when need by a salaried missionary is not imminent;
3. The trustees shall not relocate an old unit or locate a new one within the sixty days just prior to an associational meeting but they shall refer the matter to the messenger assembly;
4. A mobile unit may be recalled by the messenger assembly in any annual session, or called session.

SECTION X

May the statements of this policy never be interpreted as binding laws upon churches or missionaries, but as goals and guidelines.

GUIDELINES FOR THE USE OF THE MOBILE UNITS

- I. It is agreed that the churches of the Missionary Baptist Association of Texas will:
 - A. Provide the mobile unit;
 - B. Pay for moving the unit;
 - C. Pay for locating the unit;
 - D. Pay for major repairs brought on by physical damage outside the control of those using it, such as storm damage, vandalism and/or mechanical failure.

- II. It is agreed that the mission and/or sponsoring church will:
- A. Provide the location for the unit;
 - B. Pay for all connections, such as, water, gas, electricity, sewage;
 - C. Keep unit in good state of repair while in custody of mission and/or sponsoring church;
 - D. Pay for any and all repairs needed while in their use except those covered in Part I, Section D;
 - E. Pay for re-locating or re-setting unit while in their use.
 - F. Make no alterations in physical structure of unit without approval of trustees.
- III. After the unit is located and all connections made, the Mission Secretary, in company with the missionary and at least one member of the mission and/or sponsoring church, shall inspect the unit. The inspection shall reveal the condition of the unit at the time the mission begins using it. A written record of such findings shall be signed by both parties and a copy of same provided for both parties
- IV. A similar inspection called for in Part III shall be conducted before the unit is disconnected from the utilities at the time of moving from the custody of any mission and/or sponsoring church. The results of this inspection shall be recorded and signed by both parties.

ARTICLES OF AGREEMENT

ARTICLE I — Name

This Association shall be known as The Missionary Baptist Association of Texas.

ARTICLE II — Object

The object of this Association shall be to awaken a deeper interest in the welfare of the churches, to cultivate a closer fellowship among the churches, and to encourage and perpetuate the very greatest possible activity in missionary, educational, and benevolent enterprises.

ARTICLE III — How Composed

Section 1. This Association shall be composed of such regular independent Missionary Baptist Churches as may voluntarily choose to cooperate in carrying out the object of this Association.

Section 2. The Messenger Assemblies of this Association shall be composed of messengers elected by the churches composing it.

Section 3. Each church choosing to represent in this Association shall be entitled to three messengers.

Section 4. Each church shall be the sole judge of the qualification of her messengers.

ARTICLE IV — Nature

The Messenger Assembly of this Association shall be, in nature, formed as a council in matters pertaining to missionary, educational, and benevolent work.

ARTICLE V -- Principles

The Messenger Assembly of this Association shall recognize the freedom of speech as essential to the highest achievement in its work. It shall stand or fall on its own conformity to the truth. It shall exercise no ecclesiastical

authority, but it shall, by every precaution, recognize the independence and sovereignty of every individual church. It shall also encourage on the part of the church and the messengers the greatest possible freedom of expression in discussing matters pertaining to its work.

ARTICLE VI — Powers

The action of the Messenger Assembly shall be limited to the work of awakening enthusiasm in missionary, educational, and benevolent enterprises, and receiving and distributing funds for the same.

ARTICLE VII — Funds

Section 1. All funds of this Association shall be raised by voluntary donations secured solely upon the merits of the cause in the interest of which appeals are made for gifts; provided, this is not to prevent the use of any income or any property that may be acquired by donation or by purchase.

Section 2. Distribution of funds shall be authorized by an act of this Messenger Assembly, or by an act of properly authorized committees of this assembly hereinafter provided for; but in no instance shall the assembly or any committee of it use means in violation of the expressed preference of the donor.

ARTICLE VIII — Officers

Section 1. The officers of this Messenger Assembly shall be a moderator, an assistant moderator, two (2) recording secretaries, and a corresponding secretary-treasurer.

Section 2. All officers of this assembly shall be chosen annually, and shall hold their offices until their successors are elected and the same shall be true of all members of standing committees. All officers shall be elected by a majority of the messengers voting. No moderator shall succeed himself more than one year.

Section 3. The duties of all officers shall be as may be directed by the Messenger Assembly, unless otherwise directed by the churches.

Section 4. It shall be the duty of the corresponding secretary-treasurer to take charge of money and valuables not specifically entrusted to someone else and to dispose of same as he may be directed by this Messenger Assembly. He shall make an annual report to his assembly of all monies received and disbursed.

Section 5. The recording secretaries, in addition to keeping the records of this Association, will superintend the printing and distribution of minutes of such regular meetings as the messengers may direct.

ARTICLE IX — Committees

Section 1. The missionary committee shall be composed of one representative of each church choosing to be represented. The duty of the committee shall be to meet quarterly, or as directed by the Messenger Assembly, in the interest of all the work. It shall be empowered to fill vacancies of regular offices, between sessions of the Messenger Assembly and to call a special meeting of a Messenger Assembly when needed.

Section 2. The following standing officers of the Assembly shall be the trustees of the association: Namely, the moderator, assistant moderator, two recording secretaries, and secretary-treasurer, subject to the direction of the Messenger Assembly, and they are empowered to act in legal capacity as trustees of this Association.

ARTICLE X — Missionaries

We hold that the authority for execution of the Great Commission was given to the New Testament Church, and the authority must remain forever with the churches. Therefore, the right and privilege of every church of this Association to endorse, set apart or send out missionaries shall ever be respected. Each church may support missionaries of its own choosing, and the act of one church in sending out missionaries can in no way bind or obligate any other church. The churches shall be free and their support of missionaries shall be voluntary on their part.

ARTICLE XI — Meetings

The regular meeting of the Church Messengers shall be at such time and place as the assembled messengers may appoint.

ARTICLE XII — Amendments

The Messenger Assembly shall have no power to change the Articles of Agreement. Any church desiring a change shall send to the annual meeting a copy of the proposed change; the Messenger Assembly will then submit the proposed change to each cooperating church; if two-thirds of the cooperating churches vote for the change, then the Article of Agreement shall be amended to conform to the proposed change. Two-thirds of the churches representing in the assembly in the previous year shall be the number determining the results.

POSTER CONTEST RULES

1. Each church will be allowed to enter one poster, regardless of the number of circles or auxiliaries which they have within their church.

2. Each church will be allowed one entry in the Girl's Auxiliary poster contest, regardless of the number of Girl's Auxiliaries which they have within their church.

3. The lettering on all posters must be done by members of the Auxiliary. A person cannot be hired to do the job.

4. The posters are to be representative of the work which has been carried on throughout the last year. Pictures, facts or details should be given on the poster; making sure the project idea is carried over clearly.

5. New Projects which have been underway need to be presented on the poster.

6. The posters be of a uniform size, 22 inches X 28 inches.

7. The name of the church is not to be placed anywhere on the front of the poster. The names should be placed on the back.

8. The posters will be judged on neatness, originality and presentation of the material.

9. The poster will be carefully judged by the Advisory Council.

We further recommend that the Corresponding Secretary send each auxiliary listed in the State Minute Book and new auxiliaries a copy of the Poster Contest rules. We recommend also that the Advisory Committee, who act as Poster Contest judges, be given full instructions as to their responsibility as judges of the Poster Contest.

STATEMENT OF PRINCIPLES
TEXAS STATE WOMEN'S AUXILIARY

ARTICLE I. — Name

The name of the organization shall be Women's Auxiliary of the Missionary Baptist Association of Texas.

ARTICLE II. — Definition

The Auxiliary shall be composed of messengers of the local auxiliaries of the churches which compose the Missionary Baptist Association of Texas.

ARTICLE III. — Purpose

The purpose of this State Auxiliary shall be to encourage the women of the local churches to be active in all phases of the work in which they have the scriptural right to participate and to encourage the establishment of auxiliaries in all of our churches where none exist.

ARTICLE IV. — Time and Place

The State Auxiliary shall meet annually at 10:00 A.M. on Tuesday before annual session of the Missionary Baptist Association of Texas, or at such time as may be designated by the messenger body. The place of each meeting shall be determined by majority vote of the messengers.

ARTICLE V. — Officers

The officers of the State Auxiliary shall be (1) President; (2) First Vice-President; (3) Second Vice-President; (4) Recording Secretary; (5) Assistant Recording Secretary; (6) Treasurer; (7) Assistant Treasurer; (8) Corresponding Secretary; (9) Bible and Tract Distributor; (10) Parliamentarian; (11) Advisory Council of 3.

ARTICLE VI. — Election of Officers

All officers shall be elected annually by nomination and majority vote. No officers shall succeed herself more than once consecutively.

ARTICLE VII. — Duties of Officers

SECTION I—President

The duties of the President shall be:

(a) To preside over all State Meetings; (b) To appoint committees as directed by the Messenger Body; (c) To call special meetings when necessary; (d) To be active in looking after the welfare of the work.

SECTION II—Vice-Presidents

The duties of the First Vice-President shall be:

(a) To preside over the meetings in the absence of the President or when called upon by the President; (b) To perform the duties that usually devolve upon such officers; (c) Shall be Chairman of the Committee to Stimulate Interest.

The duties of the Second Vice-President shall be:

(a) To preside over the meeting in the absence of the President and First Vice-President or when called upon; (b) Shall be the Chairman of the Program Committee; (c) To perform the duties that usually devolve upon such officers.

SECTION III—Secretary

The duties of the Secretary shall be:

(a) To keep a record of the proceedings of the meetings; (b) To announce

special meetings; (c) To prepare and read reports as instructed by the Messenger Body; (d) To perform such other duties as may be necessary in carrying on the work of this office.

SECTION IV—Treasurer

The duties of the Treasurer shall be to receive and disburse funds as designated by the donors.

SECTION V—Corresponding Secretary

The duties of the Corresponding Secretary shall be:

(a) To correspond about necessary matters with the officers of the State Organization; (b) To report through our religious papers on the activities of Women's Work; (c) To correspond with the State Officers of other State Auxiliaries with regard to work and meetings; (d) To keep a mailing list of Auxiliaries over the state, both active and inactive.

SECTION VI—Bible and Tract Distributor

The duties of the Bible and Tract Distributor shall be:

(a) To solicit funds and receive voluntary offerings for Bible and Tract work; (b) To keep local auxiliaries informed about the needs for the carrying on of this work; (c) To supply local auxiliaries with tracts for distribution in their fields of work.

SECTION VII—Parliamentarian

The duties of the Parliamentarian shall be:

To advise the presiding officer on points of parliamentary law, and also to give similar advice to the body when they request it.

ARTICLE VIII. — Membership

Each church shall be entitled to three messengers who have been chosen by her Auxiliary and approved by the church.

ARTICLE IX. — Contributions

All contributions of this Auxiliary shall be raised by voluntary offerings and shall be given to the Treasurer for proper disbursement.

ARTICLE X. — Reports

SECTION I. This Auxiliary shall make an annual report of work accomplished by the combined Ladies Auxiliaries, to the messengers of the churches which compose the Missionary Baptist Association of Texas, when they are convened in annual session.

SECTION II. Reports of local and district auxiliary work (Personal Service Reports and other reports of work accomplished) shall be made at each annual session of this Auxiliary as provided for in the program of that meeting.

ARTICLE XI. — Committees

SECTION I. Committees shall be appointed by the President except when the President requests that they be elected.

SECTION II. A committee shall be appointed at each annual session to recommend specific plans by which Girl's Auxiliaries may be established, promoted and interest increased in the individual Girl's Auxiliaries.

SECTION III. A committee of five women, consisting of one member from each section of the State of Texas, shall be appointed for the purpose of encouraging and helping with the establishing new auxiliaries. The First Vice-President shall be chairman of this committee.

SECTION IV. A program committee shall be appointed by the President to work with the entertaining church in preparation of the program material for each annual meeting.

ARTICLE XII. — Amendment

These articles of agreement shall not be changed or amended unless the change of amendment be offered in writing during the afternoon session and permitted to lay over until night session. It may then be adopted only by a vote of two-thirds of the messengers.
